## **HAMPTON ROADS ESTATE PLANNING COUNCIL SCHOLARSHIP OF MEMBERSHIP**

Estate planning is the process of anticipating and arranging for the protection, orderly administration, and disposition of a client's wealth in accordance with their wishes, upon the occurrence of major events such as birth, marriage, divorce, incapacity, and death. Significant attention is paid to minimizing taxes and administration expenses. Estate planning requires the knowledge of state property, probate, and trust laws; and federal and state income, gift, inheritance, estate, and generation-skipping transfer tax laws.

The purpose of the Hampton Roads Estate Planning Council ("HREPC") is to promote the multi-disciplinary approach to estate planning by supporting its Members; encouraging cooperation among Members to create a thorough and comprehensive estate plan for their clients and a better understanding of the role each Member plays in the process; and to provide education and learning opportunities for its Members and to increase public awareness of the importance of estate planning by a team of professional advisers.

The HREPC members include professionals in the following fields: accounting, law, financial planning, trust administration, planned giving, and insurance, as well as allied professionals. The HREPC meets five times per year (typically the third Tuesday of the month, every other month – excluding July – from 5:15 to 7:30 p.m.) for dinner and a one hour continuing education presentation. There is also an annual half-day seminar held in May.

The Hampton Roads Estate Planning Council is pleased to announce its scholarship for an honorary one-year membership in this Council, which includes an invitation to attend each of our five dinner and educational meetings and our annual seminar (value of \$425). The scholarship is being offered to students from the following schools: Regent University, Virginia Wesleyan University, Norfolk State University, and Old Dominion University. Two scholarships total will be awarded: one for a student in the accounting/finance field of study and one from the law/prelaw field of study. The scholarship shall cover the fiscal year July 1, 2020 through June 30, 2021.

In order to be eligible, a student must:

1. Have a cumulative GPA of at least 3.0.
2. Be studying accounting, finance, or law/prelaw.
3. Be either:
  - a. In final year of a bachelor's degree during the school year that covers the period of the scholarship at one of the universities listed above;
  - b. Attending a business or accounting master's program during the school year that covers the period of the scholarship at one of the universities listed above; or
  - c. Attending Regent University School of Law during the school year that covers the period of the scholarship.
4. Be 21 years of age or older as of September 2020.

5. Submit the Applicant Information, Certification, and Official Release form, copy of official transcript, and a brief essay of 500 words or less answering one of the following questions: (1) What interests you about exploring estate planning as a career? (2) How does estate planning fit in with your studies and career aspirations at this point?
6. Agree to manage his or her schedule to the best of his or her ability in order to attend all five dinner/educational events (September, November, January, March, and May) and the half-day seminar in May.

**Applications are due by May 15, 2020. Scholarship awards will be announced by the end of May.**
